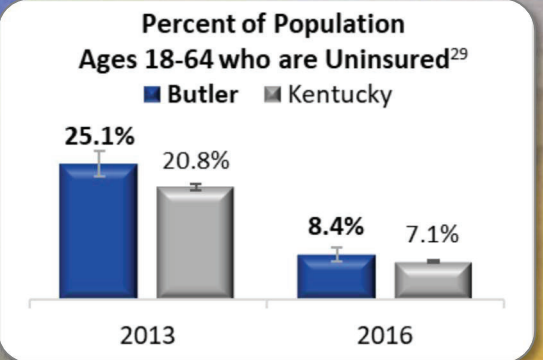

- The estimated food insecurity rate for Butler County is **15.2%**, compared to 15.5% for the state.²⁷
- From 2010 to 2016, the number of grocery stores **decreased** by **40.0%**, from **5** to **3** stores.¹⁶
- In 2013-2015, **35.7%** (28.4%-43.0%) of adults ages 20 and over reported no leisure time physical activity.²⁴
- The Urban Institute estimates that **33%** of people in Butler County with a credit bureau record in 2016 had medical debt in collections compared to 27% for the state as a whole.¹⁰
- **10.9%** (5.0%-22.3%) of adults reported that there was a time in past year when they needed to see a doctor but could not because of the cost.²⁵

The overall goals for the Community Assessments are:

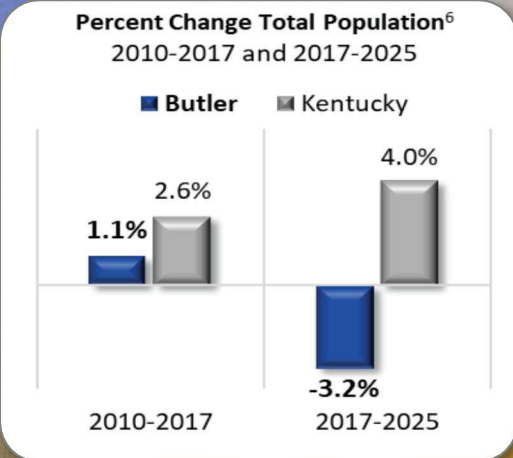
- To gain a better understanding of the county's pressing issues;

- From 2010 to 2017, the total population in Butler County **increased** by **141** people.²
- Between April 2010 and June 2017, there was an estimated **net in migration** of **48** people.⁴
- In 2016, the composition of Butler County's population is estimated to be **94.7%** White, **0.4%** Black/African American, **0.2%** Asian, **1.2%** other and 2 or more races, and **3.5%** Hispanic.⁵
- From 2017 to 2025, the total population in Butler County is **projected** to **decrease** by **-405** people.³
- As baby boomers are entering retirement, between 2010 and 2025 the population ages 65 and over in Butler County are **projected** to **increase** by **41.5%** compared to 51.9% for the state as a whole.³

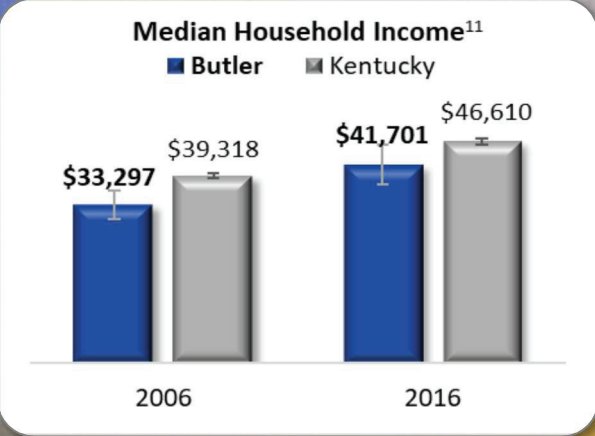

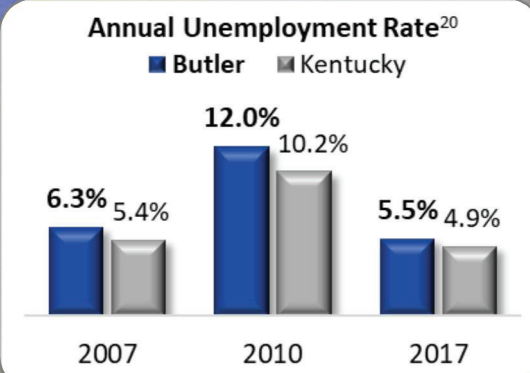

- In 2016, Butler County’s official poverty rate was **17.8%** (14.5% - 21.1%), compared to 18.2% (17.9% - 18.6%) for the state as a whole.⁸
- In 2017, there were **7** child care centers in Butler County. Of these **3** were STARS certified.⁹
- Between 2012-2016, **4.8%** (+/-1.3%) of people ages 5 and over spoke a language other than English at home.⁷
- The Urban Institute estimates that **9%** people in Butler County with a credit bureau record in 2016 had student loan debt compared to 16% for the state.¹⁰

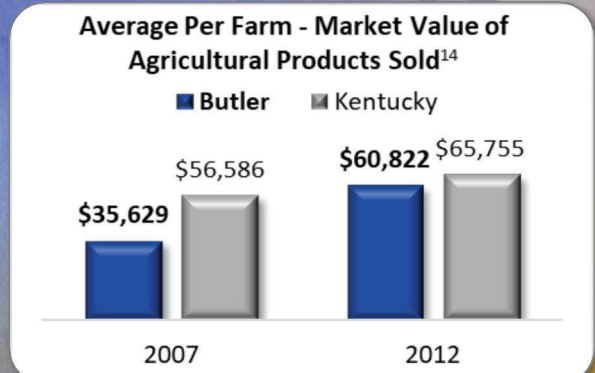

- In 2017, the number of private establishments covered by unemployment insurance in Butler County was **49** for goods-producing, **179** for service-providing, and **14** for hospitality & leisure.¹⁸
- Between 2012 and 2016, of the **5,111** (+/- 242) workers ages 16 and over, **53.8%** (+/- 4.1%) worked inside the county, **45.0%** (+/-0.9%) worked outside the county and **1.1%** (+/-0.9%) worked outside Kentucky.⁷
- Between 2012 and 2016, **5.0%** (+/-2.3%) of workers ages 16 and over who worked full-time year round were below poverty compared to 3.5% (+/- 0.1%) for the state as a whole.⁷
- **51.9%** of 2016 HS graduates in the county earned an industry certificate compared to 19.2% for the state.¹⁹

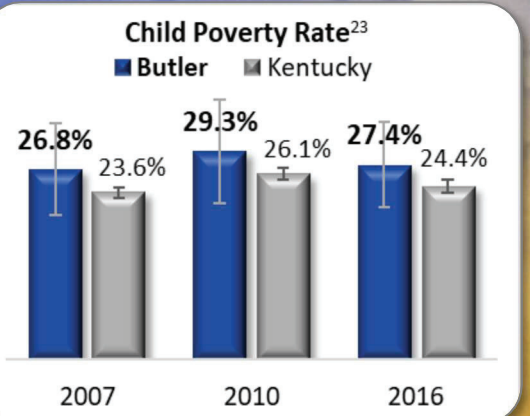

- In 2012, the total market value of agricultural products sold in Butler County was **\$42,393,000**.¹³
- Of the total market value of agricultural products sold, **54.7%** was the value of crops and **45.3%** was the value of livestock, poultry, and their products.¹³
- The total farm production expenses (average per farm) was **\$47,456** compared to \$62,002 for the state.¹³
- In Butler County, there were **349** hired farm labor workers on **124** farms.¹³
- **92.8%** of farms were operated by a family or an individual compared to 91.0% for the state.¹³

* A farm must sell at least \$5,000 to be defined as a farm operation.

18.8% of students entered KY public postsecondary institutions underprepared in one or more subjects (2015).²¹

- Between 2012-2016, there were an estimated **150** (+/-62) youth ages 5-17 who had a disability.⁷
- **26.8%** of 3rd grade students in Butler County scored proficient or distinguished on math in the 2015-16 school year compared to 47.7% for the state.²²
- **824** (+/- 188) youth under age 18 lived in households that received supplemental security income (SSI), cash public assistance, or food stamps/SNAP in the past 12 months (2012-2016).⁷
