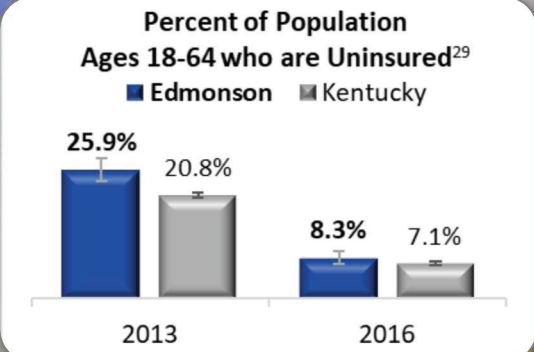

- The estimated food insecurity rate for Edmonson County is **14.9%**, compared to 15.5% for the state.<sup>27</sup>
- From 2010 to 2016, the number of grocery stores **decreased** by **50.0%**, from **4** to **2** stores.<sup>16</sup>
- In 2013-2015, **26.0%** (19.9%-32.1%) of adults ages 20 and over reported no leisure time physical activity.<sup>24</sup>
- The Urban Institute estimates that **27%** of people in Edmonson County with a credit bureau record in 2016 had medical debt in collections compared to 27% for the state as a whole.<sup>10</sup>
- **15.2%** (7.5%-28.3%) of adults reported that there was a time in past year when they needed to see a doctor but could not because of the cost.<sup>25</sup>

The overall goals for the Community Assessments are:

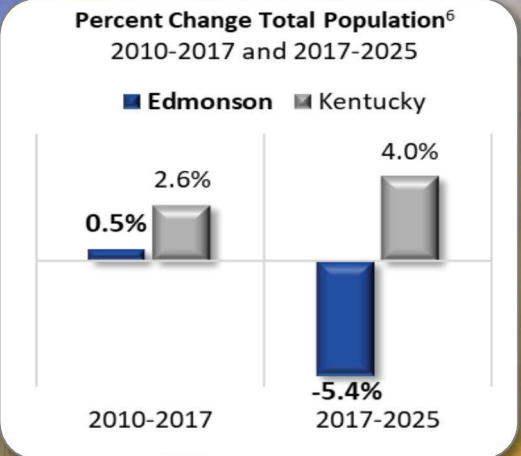
- To gain a better understanding of the county's pressing issues;

- From 2010 to 2017, the total population in Edmonson County **increased** by **65** people.<sup>2</sup>
- Between April 2010 and June 2017, there was an estimated **net in migration** of **282** people.<sup>4</sup>
- In 2016, the composition of Edmonson County's population is estimated to be **95.3%** White, **1.8%** Black/African American, **0.3%** Asian, **1.5%** other and 2 or more races, and **1.1%** Hispanic.<sup>5</sup>
- From 2017 to 2025, the total population in Edmonson County is **projected** to **decrease** by **-661** people.<sup>3</sup>
- As baby boomers are entering retirement, between 2010 and 2025 the population ages 65 and over in Edmonson County are **projected** to **increase** by **41.2%** compared to 51.9% for the state as a whole.<sup>3</sup>

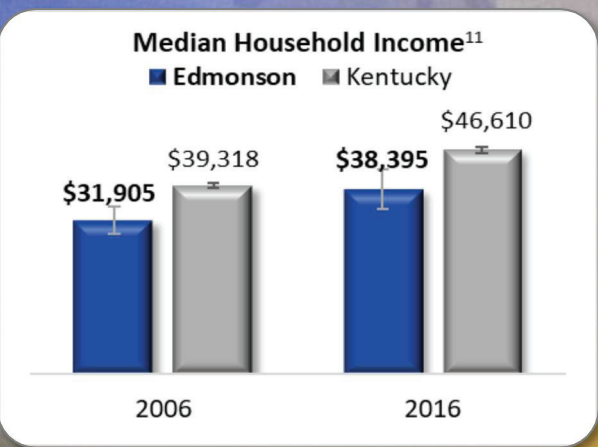

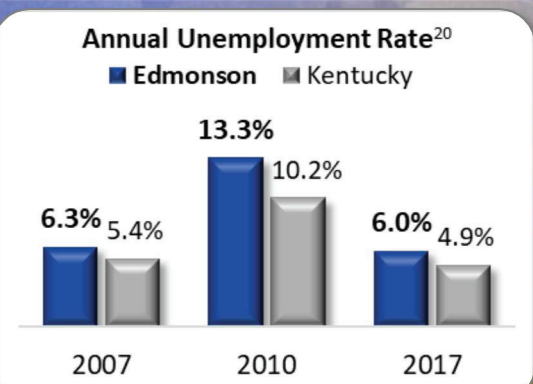

- In 2016, Edmonson County’s official poverty rate was **22.3%** (18.5% - 26.1%), compared to 18.2% (17.9% - 18.6%) for the state as a whole.<sup>8</sup>
- In 2017, there were **3** child care centers in Edmonson County. Of these **2** were STARS certified.<sup>9</sup>
- Between 2012-2016, **2.1%** (+/-1.0%) of people ages 5 and over spoke a language other than English at home.<sup>7</sup>
- The Urban Institute estimates that **15%** people in Edmonson County with a credit bureau record in 2016 had student loan debt compared to 16% for the state.<sup>10</sup>

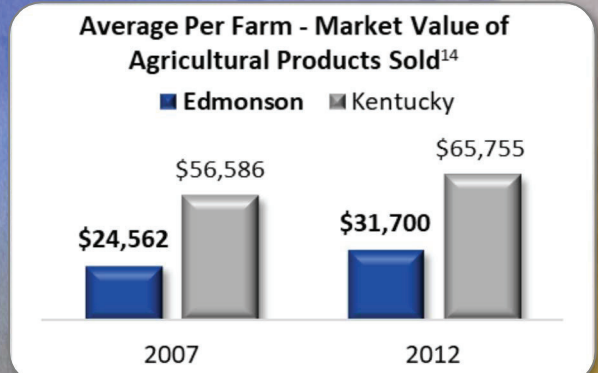

- In 2017, the number of private establishments covered by unemployment insurance in Edmonson County was **26** for goods-producing, **99** for service-providing, and **13** for hospitality & leisure.<sup>18</sup>
- Between 2012 and 2016, of the **4,420** (+/- 326) workers ages 16 and over, **25.4%** (+/- 4.3%) worked inside the county, **74.1%** (+/-0.7%) worked outside the county and **0.5%** (+/-0.7%) worked outside Kentucky.<sup>7</sup>
- Between 2012 and 2016, **3.2%** (+/-2.1%) of workers ages 16 and over who worked full-time year round were below poverty compared to 3.5% (+/- 0.1%) for the state as a whole.<sup>7</sup>
- **9.2%** of 2016 HS graduates in the county earned an industry certificate compared to 19.2% for the state.<sup>19</sup>

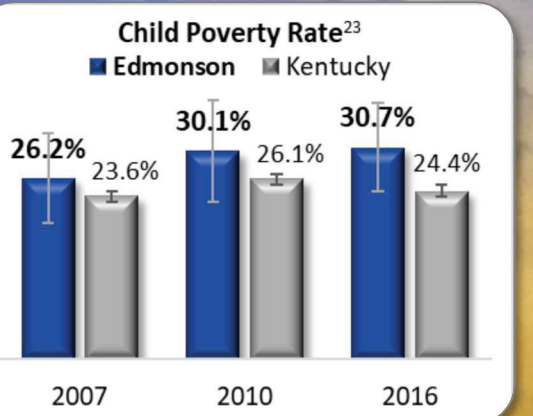

- In 2012, the total market value of agricultural products sold in Edmonson County was **\$20,224,000**.<sup>13</sup>
- Of the total market value of agricultural products sold, **33.5%** was the value of crops and **66.5%** was the value of livestock, poultry, and their products.<sup>13</sup>
- The total farm production expenses (average per farm) was **\$37,882** compared to \$62,002 for the state.<sup>13</sup>
- In Edmonson County, there were **312** hired farm labor workers on **122** farms.<sup>13</sup>
- **94.8%** of farms were operated by a family or an individual compared to 91.0% for the state.<sup>13</sup>

\* A farm must sell at least \$5,000 to be defined as a farm operation.

**26.3%** of students entered KY public postsecondary institutions underprepared in one or more subjects (2015).<sup>21</sup>

- Between 2012-2016, there were an estimated **285** (+/-122) youth ages 5-17 who had a disability.<sup>7</sup>
- **57.2%** of 3<sup>rd</sup> grade students in Edmonson County scored proficient or distinguished on math in the 2015-16 school year compared to 47.7% for the state.<sup>22</sup>
- **1,104** (+/- 301) youth under age 18 lived in households that received supplemental security income (SSI), cash public assistance, or food stamps/SNAP in the past 12 months (2012-2016).<sup>7</sup>
