- The estimated food insecurity rate for Jackson County is **19.2%**, compared to 15.5% for the state.²⁷
- From 2010 to 2016, the number of grocery stores increased by 33.3%, from 3 to 4 stores.¹⁶
- In 2013-2015, **35.5%** (29.1%-42.0%) of adults ages 20 and over reported no leisure time physical activity.²⁴
- The Urban Institute estimates that 34% of people in Jackson County with a credit bureau record in 2016 had medical debt in collections compared to 27% for the state as a whole.¹⁰
- **13.0%** (6.9%-23.2%) of adults reported that there was a time in past year when they needed to see a doctor but could not because of the cost.²⁵





In 2016, Jackson County's official poverty rate was 31.9% (26.7% - 37.1%), compared to 18.2% (17.9% - 18.6%) for the state as a whole.⁸

- In 2017, there were 5 child care centers in Jackson County. Of these 3 were STARS certified.⁹
- Between 2012-2016, **1.2%** (+/-0.7%) of people ages 5 and over spoke a language other than English at home.⁷
- The Urban Institute estimates that 12% people in Jackson County with a credit bureau record in 2016 had student loan debt compared to 16% for the state.¹⁰

- Of the total market value of agricultural products sold, 26.4% was the value of crops and 73.6% was the value of livestock, poultry, and their products.¹³
- The total farm production expenses (average per farm) was **\$23,510** compared to \$62,002 for the state.¹³
- In Jackson County, there were **385** hired farm labor workers on **119** farms.¹³
- **94.4%** of farms were operated by a family or an individual compared to 91.0% for the state.¹³




