

- The estimated food insecurity rate for Lewis County is **18.6%**, compared to 15.5% for the state.²⁷
- From 2010 to 2016, the number of grocery stores <u>decreased</u> by 14.3%, from 7 to 6 stores.¹⁶
- In 2013-2015, **32.6%** (28.1%-37.2%) of adults ages 20 and over reported no leisure time physical activity.²⁴
- The Urban Institute estimates that 38% of people in Lewis County with a credit bureau record in 2016 had medical debt in collections compared to 27% for the state as a whole.¹⁰
- 18.9% (12.6%-27.4%) of adults reported that there was a time in past year when they needed to see a doctor but could not because of the cost.²⁵


The overall goals for the Community Assessments are:

- From 2010 to 2017, the total population in Lewis County decreased by -531 people.²
- Between April 2010 and June 2017, there was an estimated net out migration of -489 people.⁴
- In 2016, the composition of Lewis County's population is estimated to be 97.7% White, 0.4% Black/African American, **0.1%** Asian, **1.1%** other and 2 or more races, and **0.7%** Hispanic.⁵
- From 2017 to 2025, the total population in Lewis County is **projected** to **decrease** by **-236** people.³
- As baby boomers are entering retirement, between 2010 and 2025 the population ages 65 and over in Lewis County are projected to increase by 41.4% compared to 51.9% for the state as a whole.3







- In 2016, Lewis County's official poverty rate was **26.8%** (22.0% 31.6%), compared to 18.2% (17.9% 18.6%) for the state as a whole.⁸
- In 2017, there were **7** child care centers in Lewis County. Of these **4** were STARS certified.⁹
- Between 2012-2016, 1.7% (+/-0.8%) of people ages 5 and over spoke a language other than English at home.
- The Urban Institute estimates that **14%** people in Lewis County with a credit bureau record in 2016 had student loan debt compared to 16% for the state.¹⁰

- In 2012, the total market value of agricultural products sold in Lewis County was \$12,806,000.13
- Of the total market value of agricultural products sold, **70.8%** was the value of crops and **29.2%** was the value of livestock, poultry, and their products.¹³
- The total farm production expenses (average per farm) was \$17,324 compared to \$62,002 for the state. 13
- In Lewis County, there were **531** hired farm labor workers on **164** farms. ¹³
- 91.7% of farms were operated by a family or an individual compared to 91.0% for the state. 13




- Between 2012 and 2016, of the **4,361** (+/- 297) workers ages 16 and over, **42.8%** (+/- 3.7%) worked inside the county, **38.9%** (+/-3.7%) worked outside the county and **18.4%** (+/-3.7%) worked outside Kentucky.⁷
- Between 2012 and 2016, **5.5%** (+/-2.3%) of workers ages 16 and over who worked full-time year round were below poverty compared to 3.5% (+/- 0.1%) for the state as a whole.⁷
- 5.8% of 2016 HS graduates in the county earned an industry certificate compared to 19.2% for the state. 19

28.6% of students entered KY public postsecondary institutions underprepared in one or more subjects (2015).²¹

- Between 2012-2016, there were an estimated 135 (+/-71) youth ages 5-17 who had a disability.
- **43.9**% of 3rd grade students in Lewis County scored proficient or distinguished on math in the 2015-16 school year compared to 47.7% for the state.²²
- **1,406** (+/- 241) youth under age 18 lived in households that received supplemental security income (SSI), cash public assistance, or food stamps/SNAP in the past 12 months (2012-2016).⁷
