



- The estimated food insecurity rate for Nicholas County is **15.9%**, compared to 15.5% for the state.²⁷
- From 2010 to 2016, the number of grocery stores **decreased** by **75.0%**, from **4** to **1** stores.¹⁶
- In 2013-2015, **32.7%** (24.9%-42.2%) of adults ages 20 and over reported no leisure time physical activity.²⁴
- The Urban Institute estimates that **43%** of people in Nicholas County with a credit bureau record in 2016 had medical debt in collections compared to 27% for the state as a whole.¹⁰
- **N/A** (N/A-N/A) of adults reported that there was a time in past year when they needed to see a doctor but could not because of the cost.²⁵

The overall goals for the Community Assessments are:


- To gain a better understanding of the county's pressing issues;

- From 2010 to 2017, the total population in Nicholas County **decreased** by **-5** people.²
- Between April 2010 and June 2017, there was an estimated **net in migration** of **94** people.⁴
- In 2016, the composition of Nicholas County's population is estimated to be **96.1%** White, **0.7%** Black/African American, **0.2%** Asian, **0.9%** other and 2 or more races, and **2.1%** Hispanic.⁵
- From 2017 to 2025, the total population in Nicholas County is **projected to decrease** by **-133** people.³
- As baby boomers are entering retirement, between 2010 and 2025 the population ages 65 and over in Nicholas County are **projected to increase** by **27.9%** compared to 51.9% for the state as a whole.³





- In 2016, Nicholas County's official poverty rate was **19.8%** (16.0% - 23.6%), compared to 18.2% (17.9% - 18.6%) for the state as a whole.⁸
- In 2017, there were **1** child care centers in Nicholas County. Of these **1** were STARS certified.⁹
- Between 2012-2016, **4.3%** (+/- 3.4%) of people ages 5 and over spoke a language other than English at home.⁷
- The Urban Institute estimates that **12%** people in Nicholas County with a credit bureau record in 2016 had student loan debt compared to 16% for the state.¹⁰



- In 2017, the number of private establishments covered by unemployment insurance in Nicholas County was **15** for goods-producing, **66** for service-providing, and **6** for hospitality & leisure.¹⁸
- Between 2012 and 2016, of the **2,776** (+/- 204) workers ages 16 and over, **36.2%** (+/- 5.9%) worked inside the county, **63.5%** (+/- 0.6%) worked outside the county and **0.3%** (+/- 0.6%) worked outside Kentucky.⁷
- Between 2012 and 2016, **8.6%** (+/- 3.2%) of workers ages 16 and over who worked full-time year round were below poverty compared to 3.5% (+/- 0.1%) for the state as a whole.⁷
- 27.3%** of 2016 HS graduates in the county earned an industry certificate compared to 19.2% for the state.¹⁹




- In 2012, the total market value of agricultural products sold in Nicholas County was **\$20,739,000**.¹³
- Of the total market value of agricultural products sold, **50.6%** was the value of crops and **49.4%** was the value of livestock, poultry, and their products.¹³
- The total farm production expenses (average per farm) was **\$37,269** compared to \$62,002 for the state.¹³
- In Nicholas County, there were **752** hired farm labor workers on **162** farms.¹³
- 88.8%** of farms were operated by a family or an individual compared to 91.0% for the state.¹³

* A farm must sell at least \$5,000 to be defined as a farm operation.

- Between 2012-2016, there were an estimated **64** (+/- 41) youth ages 5-17 who had a disability.⁷
- 35.6%** of 3rd grade students in Nicholas County scored proficient or distinguished on math in the 2015-16 school year compared to 47.7% for the state.²²
- 711** (+/- 178) youth under age 18 lived in households that received supplemental security income (SSI), cash public assistance, or food stamps/SNAP in the past 12 months (2012-2016).⁷
