

- The estimated food insecurity rate for Russell County is 17.1%, compared to 15.5% for the state.²⁷
- From 2010 to 2016, the number of grocery stores increased by 16.7%, from 6 to 7 stores. 16
- In 2013-2015, 29.7% (23.6%-36.3%) of adults ages 20 and over reported no leisure time physical activity.²⁴
- The Urban Institute estimates that 34% of people in Russell County with a credit bureau record in 2016 had medical debt in collections compared to 27% for the state as a whole.¹⁰
- 15.5% (8.1%-27.8%) of adults reported that there was a time in past year when they needed to see a doctor but could not because of the cost.²⁵


The overall goals for the Community Assessments are:

- From 2010 to 2017, the total population in Russell County increased by 210 people.²
- Between April 2010 and June 2017, there was an estimated **net in migration** of **277** people.⁴
- In 2016, the composition of Russell County's population is estimated to be 93.9% White, 0.8% Black/African American, **0.4%** Asian, **1.3%** other and 2 or more races, and **3.6%** Hispanic.⁵
- From 2017 to 2025, the total population in Russell County is **projected** to **increase** by **403** people.³
- As baby boomers are entering retirement, between 2010 and 2025 the population ages 65 and over in Russell County are projected to increase by 34.6% compared to 51.9% for the state as a whole.³





- In 2016, Russell County's official poverty rate was **25.0%** (20.5% 29.5%), compared to 18.2% (17.9% 18.6%) for the state as a whole.⁸
- In 2017, there were 13 child care centers in Russell County. Of these 9 were STARS certified.9
- Between 2012-2016, 3.5% (+/-1.1%) of people ages 5 and over spoke a language other than English at home.
- The Urban Institute estimates that **13**% people in Russell County with a credit bureau record in 2016 had student loan debt compared to 16% for the state.¹⁰

- In 2012, the total market value of agricultural products sold in Russell County was \$44,526,000.¹³
- Of the total market value of agricultural products sold, **16.1%** was the value of crops and **83.9%** was the value of livestock, poultry, and their products.¹³
- The total farm production expenses (average per farm) was \$62,175 compared to \$62,002 for the state. 13
- In Russell County, there were 427 hired farm labor workers on 196 farms.¹³
- 93.4% of farms were operated by a family or an individual compared to 91.0% for the state. 13




Women

- Between 2012 and 2016, of the 6,013 (+/- 355) workers ages 16 and over, 75.8% (+/- 3.4%) worked inside the county, 23.1% (+/-0.8%) worked outside the county and 1.1% (+/-0.8%) worked outside Kentucky.⁷
- Between 2012 and 2016, **4.5%** (+/-1.8%) of workers ages 16 and over who worked full-time year round were below poverty compared to 3.5% (+/- 0.1%) for the state as a whole.⁷
- 44.8% of 2016 HS graduates in the county earned an industry certificate compared to 19.2% for the state. 19

33.3% of students entered KY public postsecondary institutions underprepared in one or more subjects (2015).²¹

- Between 2012-2016, there were an estimated 161 (+/-78) youth ages 5-17 who had a disability.
- **39.5%** of 3rd grade students in Russell County scored proficient or distinguished on math in the 2015-16 school year compared to 47.7% for the state.²²
