

- The estimated food insecurity rate for Spencer County is 9.7%, compared to 15.5% for the state.²⁷
- From 2010 to 2016, the number of grocery stores <u>decreased</u> by 75.0%, from 4 to 1 stores.¹⁶
- In 2013-2015, 27.9% (20.7%-36.1%) of adults ages 20 and over reported no leisure time physical activity.²⁴
- The Urban Institute estimates that 19% of people in Spencer County with a credit bureau record in 2016 had medical debt in collections compared to 27% for the state as a whole. 10
- 7.8% (3.0%-18.7%) of adults reported that there was a time in past year when they needed to see a doctor but could not because of the cost.²⁵

- To provide a statewide view of how top issues are distributed across the state.



- From 2010 to 2017, the total population in Spencer County increased by 1,446 people.²
- Between April 2010 and June 2017, there was an estimated **net in migration** of **1,030** people.⁴
- In 2016, the composition of Spencer County's population is estimated to be 94.3% White, 1.6% Black/African American, **0.4%** Asian, **1.5%** other and 2 or more races, and **2.1%** Hispanic.⁵
- From 2017 to 2025, the total population in Spencer County is **projected** to **increase** by **2,562** people.³
- As baby boomers are entering retirement, between 2010 and 2025 the population ages 65 and over in Spencer County are projected to increase by 122.0% compared to 51.9% for the state as a whole.3





- In 2016, Spencer County's official poverty rate was 8.8% (7.1% 10.5%), compared to 18.2% (17.9% 18.6%) for the state as a whole.8
- In 2017, there were 6 child care centers in Spencer County. Of these 4 were STARS certified.⁹
- Between 2012-2016, 2.1% (+/-1.1%) of people ages 5 and over spoke a language other than English at home.⁷
- The Urban Institute estimates that 13% people in Spencer County with a credit bureau record in 2016 had student loan debt compared to 16% for the state. 10

- In 2012, the total market value of agricultural products sold in Spencer County was \$15,614,000.13
- Of the total market value of agricultural products sold, 66.0% was the value of crops and 34.0% was the value of livestock, poultry, and their products.¹³
- The total farm production expenses (average per farm) was \$29,051 compared to \$62,002 for the state.¹³
- In Spencer County, there were 437 hired farm labor workers on 118 farms. 13
- 87.2% of farms were operated by a family or an individual compared to 91.0% for the state. 13





- In 2017, the number of private establishments covered by unemployment insurance in Spencer County was 55 for goods-producing, 215 for service-providing, and 20 for hospitality & leisure. 18
- Between 2012 and 2016, of the **8,667** (+/- 443) workers ages 16 and over, **17.5%** (+/- 3.4%) worked inside the county, **79.7%** (+/-1.4%) worked outside the county and **2.8%** (+/-1.4%) worked outside Kentucky.⁷
- Between 2012 and 2016, 0.2% (+/-0.3%) of workers ages 16 and over who worked full-time year round were below poverty compared to 3.5% (+/- 0.1%) for the state as a whole.⁷
- 13.7% of 2016 HS graduates in the county earned an industry certificate compared to 19.2% for the state.

18.0% of students entered KY public postsecondary institutions underprepared in one or more subjects (2015).²¹

- Between 2012-2016, there were an estimated **215** (+/-99) youth ages 5-17 who had a disability.⁷
- 59.5% of 3rd grade students in Spencer County scored proficient or distinguished on math in the 2015-16 school year compared to 47.7% for the state.²²
- 527 (+/- 193) youth under age 18 lived in households that received supplemental security income (SSI), cash public assistance, or food stamps/SNAP in the past 12 months (2012-2016).⁷
